He has handled investigations and prosecutions conducted by a range of UK authorities, including the Serious Fraud Office, the Financial Conduct Authority, the Competition and Markets Authority, Trading Standards, the Solicitors Regulation Authority, and The Insolvency Service. Tom previously practiced as a Principal Investigative Lawyer within the Bribery & Corruption Division of the UK's Serious Fraud Office and draws on this experience when advising clients on compliance and defence strategies.

The breadth of Tom's experience across commercial disputes and regulatory matters makes him ideally placed to assist corporations and senior executives in navigating complex contentious matters involving parallel investigations, inquiries and litigation.

Tom is regularly recognized in the legal directories.
